Gilbert Plains WDS has been under review of their operations this past year. The goal is to operate the landfill in the most efficient manner to our taxpayers. What are the best options? Turn it into a COOP? Go larger with Regionalization? Go smaller and set up for Gilbert Plains Residents only?

Waste is a growing concern, managing waste and minimizing the amount entering the cells is crucial to operating efficiently. Increasing our diversion rate opens opportunities for the landfill to grow with the continuous requirements of waste management.

Unfortunately at this time we had to shut down the Shredder, Waste is being hauled and packed directly into the pit while options are being evaluated on how to proceed with the Shredder repairs versus purchasing a new unit.

Being diligent in our recycling efforts during this time,
will help minimize the waste entering the cell. We

BY-LAW 2004 ANIMAL CONTROL

Whereas subsection 232(1) of The Municipal Act provides, in relevant part, as follows: 232(1) A Council may pass by-laws for Municipal Purposes:

It has been an interesting year for our Public Workshop Department. Losing their shop to a fire and being rehomed to the old town office has been quite the challenge, which they have met.

A team of engineers are now working on finalizing the blue prints. Due to the size of the claim we have been assigned a team of Cost Consultants by the insurance company to oversee the project.
