ANIMALS AT LARGE

BY-LAW 2004 ANIMAL CONTROL

Whereas subsection 232(1) of The Municipal Act provides, in relevant part, as follows: 232(1) A Council may pass by-laws for Municipal Purposes:

(k) wild and domestic animals and activities in relation to them

SECTION 5(1)

No owner or person in charge of an animal shall allow it to run at large.

We appreciate your continued assistance in keeping our community and your pets safe

UNSIGHTLY PROPERTIES

BY-LAW NO. 2010-07

No owner or occupier of property shall permit on such property, and each owner and occupier of property shall keep such property free and clear of:

- a. Rubbish;
- b. unsafe structure(s);
- c. unsightly property;
- d. the storage of motor vehicles capable of registration under the Highway Traffic Act or the Off-Road Vehicles Act, which are not registered under either of those statutes, unless the said property and/or structures are lawfully used and licensed as a commercial automobile dealership;
- e. the storage of more than one registered vehicle provided the vehicle is registered to the owner of the property;
- f. the storage of motor vehicles and machinery not capable of registration, unless the said property owner is licensed as a commercial automobile dealership
- g. the storage of household appliances, whether or not the same are capable of operation; the growth of weeds as defined in *The Noxious Weeds Act*
